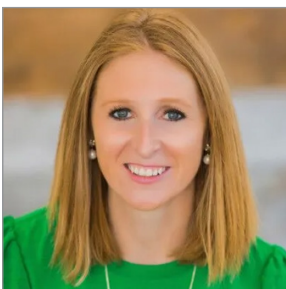

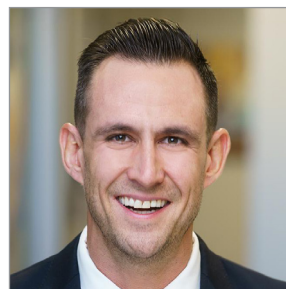

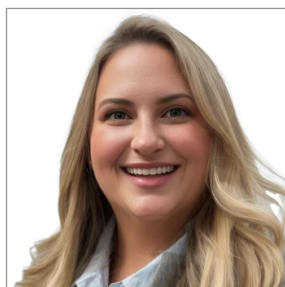

MAKE A DIFFERENCE – HUB'S PUB
