WHAT IS THE CDLA FOUNDATION?

The Foundation was created by the CDLA to raise funds for worthy charities and causes and to serve the Colorado community on behalf of the CDLA membership. Each year at the Annual Conference, the CDLA holds a “Hub’s Pub” event/raffle in honor of Daniel M. Hubbard, a former incoming president of the CDLA, who suffered a cardiac incident while riding his bicycle home from work and passed away. The funds raised at Hub’s Pub are used to fund the Foundation and in memory of Dan Hubbard and his passion for cycling, a portion of those proceeds are used to donate bicycles to Children’s Hospital and to children served through Adams, Broomfield and Jefferson County Court Appointed Special Advocates (CASA). Since its inception, the Hub’s Pub event has donated 314 bicycles and raised over \$125,732. Funds are also donated to various causes including, but not limited to, Food Bank of the Rockies, Project C.U.R.E., Alzheimer’s Association, Jessie’s Heart, Florence Crittenton Services, and “Law School...Yes We Can.”
